



## MEMORANDUM OF UNDERSTANDING

#### between

# College of Computing, Prince of Songkla University, THAILAND and

Faculty of Business and Economics, Mendel University in Brno, CZECH REPUBLIC

The College of Computing of Prince of Songkla University and the Faculty of Business and Economics of Mendel University in Brno enter the following terms of this Memorandum of Understanding (MoU) with respect to furthering international cooperation in research and education.

## **ARTICLE 1: PURPOSE**

The parties pledge themselves to cooperate in a spirit of greater understanding, to deepen friendly relationships and ties of mutual benefit, and to foster collaboration. The parties will undertake to initiate joint activities, including, but not limited to:

- Cooperation in research activities;
- Exchange of faculty members;
- Exchange of students;
- Exchange of scientific materials, publications and information;
- Organizing academic seminars;
- Other activities as would be agreed upon by both parties.

Details of the implementation of any particular exchange resulting from this agreement shall be negotiated between the two institutions.

#### ARTICLE 2: FINANCIAL

The MoU does not create a financial obligation between the parties; therefore, no money shall be exchanged between the parties. In order to finance these activities, the parties will undertake to obtain the necessary financial assistance from institutions, both private and public, providing support for such cooperative programs.

### **ARTICLE 3: OTHER PROVISIONS**

This MoU constitutes the entire agreement between the parties. There are no understandings or representations, oral or written, not specified in this MoU. No amendment, consent, or waiver of the terms of the MoU shall bind the parties unless it is in writing and signed by all parties.

# ARTICLE 4: EFFECTIVE DATE AND DURATION

This MoU is valid for five (5) years from the date of signing. It may be extended by mutual consent upon a request for renewal along with a report of the activities pursued under the auspices of this MoU, submitted prior to its date of expiration.

## **ARTICLE 5: TERMINATION**

The parties may terminate the present agreement prior to the expiration date by giving thirty (30) days' prior written notice. In the case of termination, programs already in progress shall be concluded in an orderly fashion.

# ARTICLE 6: REPRESENTATIONS AND WARRANTIES

The signatories of this MoU agree and affirm that they have the authority to bind their institutions. This MoU is not legally binding under national or international law. Its sole purpose is to promote collaboration.
